

Sign Up for the Procurement Skills Accord 2019/20 is Now Open

We are now welcoming signups for the 2019/20 Procurement Skills Accord from sector employers.

Sector employers are being encouraged to consider signing up to an initiative that has helped leading UK gas, power and water companies drive investment in training and skills, in areas where the sector needs them most, through procurement.

The Procurement Skills Accord was created in response to the 2015 National Infrastructure Plan for Skills, as a mechanism to incentivise skills investment through procurement and engagement approaches that would provide appropriate incentives to retrain and up-skill the workforce to meet future skills demands.

The energy and utilities sector's work to meet this challenge through the Procurement Skills Accord was recognised and welcomed by Her Majesty's Treasury and was one of the core initiatives identified within the <u>Workforce Renewal and Skills Strategy</u>.

Since the Accord was piloted in 2016, the number of signatories has since grown from 26 to 56 organisations participating last year.

Signatories must commit to the following five commitments:

- 1. To address sector-wider skills gaps and shortages
- 2. To promote signing up to the Accord through the supply chain
- 3. To promote relevant skills development across the supply chain through procurement
- 4. To continuously improve performance
- 5. To monitor and report

The Procurement Skills Accord has helped its signatories record encouraging outcomes, showing that these companies have adapted their procurement process and culture to ensure that they are investing in the skills and training that the sector needs– within the asset owners and their supply chain companies.



Those outcomes include:

- Skills development is becoming a recognised and valued part of procurement activity with 76% of relevant companies embedding skills development into their procurement processes
- Training volumes** increased from 11% to 15% over the year and 5% of the operational/technical workforce are on apprenticeship programmes
- Procurement and Learning & Development specialists are beginning to work constructively together
- Skills development principles included in Achilles Utility Vendor Database
- There is an increasing wealth of best practice being shared across the industry and over 80% of signatories would recommend joining the Procurement Skills Accord to others
